Sub: Lands - Visakhapatnam district - Anandapuram Mandal -Miss. H.I.Vellies, Ex-Servicewoman granted assignment for the Land measuring Ac.4.56 cts covered by Sy.No.76/5 of Gudilova village- withdrawal of the land from Sec.22-A of Registration Act -Orders issued.

ORDER:

Sri Ch.Madhusudhanam, a resident of Visakhapatnam has submitted a representation, in the reference 6th read above, stating that he purchased the land measuring Ac.4.56 cts covered by Sy.No.76/5 of Gudilova village of Anandapuram Mandal from Miss. H.I.Vellis, Ex-servicewoman in terms of G.O.Ms.No.1117 dt.11.11.1993 and in pursuance of the orders of the Hon'ble High Court of AP, Hyderabad in W.P.No.19086/2006 vide Regd.Doc. No.436/2007. Therefore, he requested for de-notiification of the land from the list of Govt. lands notified U/s 22-A of Registration and also to issue PPB/TD etc.

As seen from the reports of Mandal Revenue Officer, Anandapuram and RDO Visakhapatnam, and as verified the connected records, it reveals that, Kum H.I.Vellis, Ex-Servicewoman was granted patta for an extent of Ac.4.56 cts in Sy.No.76/5 of Gudilova village of Anandapuram Mandal vide D.R No.341/1376 dt.16.04.1969, while she was in service. Subsequently she sold away the land to the applicant on the strength of Govt. Orders vide G.O.Ms.No.1117 Revenue (ASN.1) Dept Dt. 11.11.1993. In which, the Govt. have issued orders that, the ex-servicemen are free to sell away their assigned lands after a period of 10 years from the date of assignment.

In the circumstances stated above, the land measuring Ac.4.56 cts covered by Sy.No.76/5 of Gudilova village of Anandapuram Mandal is hereby withdrawn from the list of Govt. lands notified U/s Sec.22-A of Registration Act.

The Sub-Registrar, Anandapuram is requested to take necessary further action in the matter.
