ORDER:

Sri M.Gangadhararao, Ex-Serviceman of World War-II, resident of Kannuru village of Parawada Mandal has submitted a representation requesting for issue of NOC to sell away the land measuring Ac.5.00 cts in Sy.No.448 of Peda Mushidivada Village of Parawada Mandal, which was assigned in his favour vide D.R No.78/1402 dt.05.06.1993.

The Tahsildar, Parawada and the Revenue Divisional Officer, Visakhapatnam have reported that, the assignee was granted Pattadar Pass Book/Title Deed and the land in question is in his possession and enjoyment by raising cashew and Eucalyptus garden. As the assignee worked during World War-II and the assignment was granted in the year 1993 i.e after cut off date, the matter was referred to the Government to examine and to issue suitable orders.

The Government vide Memo 6th read above have accorded permission to grant of NOC to the individual to sell away the land in terms of G.O.Ms.No.1117 Revenue (ASN.1) Dept Dt.11.11.1993, and requested the Collector to take necessary further action.

Therefore, Sri M.Gangadhararao, Ex-Servicemen is hereby granted NOC to sell away the land measuring Ac.5.00 Cts in Sy.No.448 of Peda Mushidivada village of Parawada Mandal in terms of G.O.Ms.No.1117 Revenue (ASN.1) Dept Dt.11.11.1993. Further, the land in question is hereby withdrawn from the purview of Sec.22-A of Registration Act,1908.
