ORDER:

The Govt. in their memo dt.25.07.2008 vide reference read above, has accorded permission to Smt Rangoori Meenakshi, Wife of Late Apparao Freedom Fighter/Political Sufferer to sell away the land measuring Ac.10.00 cts assigned to her in Sy.No.399 and 400/1 which was carved out from Sy.No.314 (Hill Poramboke) of Kapuluppada village of Bheemunipatnam mandal, as a special case in relaxation of G.O.Ms.No.1045 Revenue (assn.I) Dept Dt. 15.12.2004. Further, the Govt. have directed the District Collector, Visakhapatnam to take necessary action in the matter. At the time of submission of report to the Govt. on the representation of the assignee to accord permission to sell away the above said land, it was reported to the Govt. that the assignee is having the following heirs.

Since the survey numbers of 399 and 400/1 have been carved out from the Sy.No.314 (Hill Poramboke) of Kapuluppada village of Bheemunipatnam mandal which was notified under Sdec.22-A of registration act, the land measuring Ac.2.99 cts in Sy.No.399 and Ac.7.01 cts in Sy.No.400 of Kapuluppada village is withdrawn from Sec.22-A of registration act to facilitate registrations on the said land as the Govt. have accorded permission to the assignee to sell away the land in relaxation of G.O.Ms.No.1045 Revenue (Assn.I) Dept Dt.15.12.2004.

Therefore, the Sub-Registrar, Bheemunipatnam is directed to allow the sale transactions on the above said land.
