ORDER

Sri Suriseti Appalakonda, Ex-Serviceman, vide reference 1st read
above, has submitted a representation requesting to issue NOC to sell away the
land measuring Ac.5.00 cts covered by Sy.No.13 Part of Y.B.Agraharam Village of
Nathavaram Mandal, which was said to have been assigned to him vide D.C No
767/80 Dt.26.09.1970, to meet the medical expenses and also to perform his
daughter's marriage.

The Tahsildar, Nathavaram and the Revenue Divisional Officer,
Visakhapatnam, vide reference 2nd and 3rd read above respectively, have
submitted their reports on the subject matter of the land, stating that the
applicant was issued D-Form patta for Ac.5.00 Cts in Sy.No.13 Part of
Y.B.Agraharam Village of Nathavaram Mandal vide D.C No.767/80
Dt.26.09.1970. On verification of the D-Patta, it appears to be granted during
Assignments crash programme duly imposing a condition that "the Extent and
assessment are subject to revision after survey and subdivision". As such, it was
directed the Tahsildar, Nathavaram to get it done survey of land and arrive
correct extent. Accordingly, the land got surveyed, the extent arrived at Ac.4.00
Cts and the Survey Number was denoted as 13/1. The Tahsildar has also made
necessary corrections in the connected records as well as on the D-Form Patta.

Further, as per the provision laid down, vide G.O.Ms.No.1117
Revenue (Assignment) Dept Dt.11.11.1993, the Ex-servicemen are at liberty to sell
away their assigned lands after a period of 10 years from the date of assignment.

Therefore, Sri Suriseti. Appalakonda, Ex-Serviceman is hereby permitted to sell away the land measuring Ac.4.00 cts covered by Sy.NO.13/1 of Y.B.Agraharam Village of Nathavaram Mandal. Further, the land in question is hereby deleted from the list of Govt. lands furnished to the Sub-Registrar, Kotauratla U/s 22-A.

The Sub-Registrar, Kotauratla is requested to take necessary action.
