ORDER:

Sri Vaddadi Sanyasirao, S/o Nookanna, Ex-Serviceman was granted D-Form Pata in respect of Hill Poramboke land with an extent of Ac.4.65 Cts covered by Sy.No.441/1 of Pedamushidivada village of Parawada mandal vide D.R No.6/1401 dt.05.01.1992 as reported by the Tahsildar, Parawada and RDO Visakhapatnam read with the certificate issued by the Zilla Sainik Welfre Officer, Visakhapatnam, Pension Payment Order and Discharge Certificates produced by the D-Form Patta holder.

As the individual was granted assignment while he was in service, it was requested the Govt. to clarify whether the individual comes under the purview of G.O.Ms.No.1117 Dt.11.11.1993. The Government, in their Memo 5<sup>th</sup> read above, have clarified that, the Ex-Servicemen are free to sell away their assigned lands after a period of 10 years and the spirit of the G.O.Ms.No.1117 Rev Dt.11.11.1993 itself is consideration for the period of 10 years from the date of assignment, and the date of discharge of the personal from the service need not be taken into consideration in this case, and also requested the Collector to take necessary action for issue of NOC.

Therefore, the request of the individual is hereby considered and granted NOC to sell away the land. Further, the land measuring Ac.4.65 Cts covered by Sy.NO.441/1 of Pedamushidivada village of Parawada Mandal is hereby withdrawn from the list of Govt. Lands notified u/s 22-A of Registration Act, 1908.

The Sub-Registrar, Lankelapalem is requested to take further necessary action in the matter.
