I invite attention to the references cited.

Sri Maddala Jaggarao, Ex-Serviceman has put in an application for
issuance of NOC to sell away his assigned land for an extent of Ac.4-85 cts covered
by Sy.No.362/1 of Koduru village of Anakapalli mandal.

As per the reports of the Tahsildar Anakapalli and the Revenue
Divisional Officer, Visakhapatnam and pursuant to the enquiry held by the Joint
Collector, Visakhapatnam it is found that Sri Maddala Jaggarao, Ex-serviceman was
assigned an extent of Ac.4.85 cts of Govt. dry land in Sy.No.362/1 of Koduru village
of Anakapalli mandal vide D.R.No.1/92/A3 Dt.01.07.1982.

Further, in terms of G.O.Ms.No. 1117 Revenue (Assignment) Dept
Dt.11.11.1993, the ex-servicemen are free to sell away their assigned lands after
completion of 10 years of period from the date of assignment.

Therefore, the assignment made in favour of Sri M.Jaggarao, Ex-
Serviceman for the land admeasuring for Ac.4.85 cts in Sy.No.362/1 of Koduru
village of Anakapalli mandal is confirmed as genuine one and the land in question is
withdrawn from Sec.22- A registration act.
