ORDER:

Sri Botcha Manohar Kumar, Botcha Jayasheela Rao and Dr Botcha David Gandhi R/o Chandrakanthi Door No: 12-3-14, Saradha Colony, Anakapalli have put in representations stating that his late father Sri Botcha Alexander was assigned Government land measuring Ac. 5-07cts during the year 1970 vide D-For Patta (DR No.1347/29/dt.25-09-1971) under ex-serviceman quota and since then the land was cultivating by his father by planting casuarina topes .Consequent to the death of parents, the land was distributed among the legal heirs and now they want to sell away their share of the land measuring Ac.4-07cts since then they are cultivating the above lands and to meet the expenditure on medical treatment as per the G.O.1117/dt.11-11-93.

The applications got enquired and that the Government land measuring Ac. 5-07cts in S.No.326/5 (carved out from S.No.326) of Desapatrunipalem village was assigned in favour of Sri B.Alexander vide DR No.1347/79 under Ex-serviceman quota by the erstwhile Tahsildar, Anakapalli and after the death of the assignee the land was apportioned between 3 sons and daughter as detailed below.

In this case D.R. file is available which clearly shows assignment is in favour of B-Alexander. According to the Village Account 10(1) entry is also there in the name of Alexander. Further 10 years is already lapsed from the date of issue of Patta and the land is also under cultivation.

In view of the above circumstances, and according to the reports of the Tahsildar, Parawada and the Revenue Divisional Officer, Visakhapatnam and as per the provisions laid down in G.O.1117 Revenue (ASN-I) Department dt.11-11-93, Permission is hereby accorded to the following legal heirs of the assignee (i.e. applicants) to sell away the land measuring **Ac.4-07cts** only out of the assigned land Extent of Ac.5-07cts assigned to Sri Botcha Alexander under Ex-serviceman Quota in S.No.326/5 (carved out from S.No.326) of Desapatrunipalem village as detailed below.
