ORDER:

In the reference 3rd read above, the Govt. have allowed the Revision
Petition filed by Sri Komara Appanna S/o Appanna, Ex-Serviceman against the Orders
dated 11.12.2007 of the Joint Collector, Visakhapatnam in respect of the land
measuring Ac.5.00 cts covered by Sy.No.354/2 of Madhurawada Village of
Visakhapatnam (Rural) Mandal. The Govt. further accorded permission to the
Collector, Visakhapatnam to incorporate the name of Revision Petitioner in Revenue
records and to issue NOC for disposal of the land assigned to him

Therefore, the Tahsildar, Visakhapatnam (Rural) is directed to
incorporate the name of Sri K.Appanna, Ex-Serviceman in connected records for the
land measuring Ac.5.00 cts covered by Sy.No.354/2 of Madhurawada Village. Further,
permission is hereby accorded to Sri K.Appanna to dispose of the land as per the
provision laid down vide G.O.Ms.No.1117 Revenue (ASN.1) Dept Dt.11.11.1993, and
the land in question is hereby withdrawn from the list of Government Lands reported
to the Sub-Registrar, Madhurawada under Sec,22-A of Registration Act.

The Tahsildar, Visakhapatnam (Rural) and Sub-Registrar, Madhurawada
are requested to take necessary further action in the matter.
