ORDER:

In the reference 1st read above, the Sub-Registrar, Ellamanchili has informed that, the following 4 persons have presented sale deeds for registration of the land covered Sy.Nos.161/1, 2, 3 & 4 of Haripuram village of Rambilli Mandal, which was said to have been assigned in their favour under Ex-Servicemen quota,. The sale deeds were presented, as per the provision laid down vide G.O.ms.No.1117 Dt.11.11.1993. The Sub-Registrar has requested to issue necessary confirmation as to the genuineness of said assignments.

In the reference 2nd and 3rd read above, the Tahsildar, Rambilli and the RDO Narsipatnam have submitted reports respectively, which, discloses that, the above 4-exservicemen were granted D-Form Pattas in Sy.No.161/1,2,3 and 4 for the extents as noted against each under Ex-servicemen category, and it is in their possession and enjoyment.

Further, as per the provision laid down vide G.O.Ms.No.1117 Revenue Dept Dt.11.11.1993, the Ex-Servicemen are free to sell away their assigned lands after a period of 10 years from the date of Assignment.

Therefore, in the circumstances stated above, the assignment granted in favour of above said 4 ex-servicemen are hereby confirmed as genuine. Further, the land covered by Sy.No.161/1, 2, 3 and 4 of Haripuram Village of Rambilli Mandal for a total extent of Ac.18.83 Cts is hereby deleted from the purview of Sec.22-A of Registration Act.

The Sub-Registrar, Ellamanchili is requested to take necessary further action in the matter.
