ORDER:

Pursuant to the references 1<sup>st</sup> to 5<sup>th</sup> read above, Sri L.R.Patric, Ex-Serviceman was assigned Govt. land measuring Ac.5.00 cts covered by Sy.No.39/2 of Kommadi village of Visakhapatnam (Rural) vide D.R.No.327/61 dt. 15.04.1961 and the changes were mutated in connected revenue records.

In terms of G.O.Ms.No.1117 Revenue (Assignment) Dept, Dt.11.11.1993, the ex-servicemen are free to sell away their assigned lands after completion of 10 years from the date of assignment. Accordingly, the wife of the assignee has sold away it through GPA to Smt. D.hema Lalithambika for Ac.3.00 cts vide regd. doc No.1336/94 dt.07.10.1994 and Ac.2.00 cts to Sri T.Raghavaraju vide regd. Doc.No. 1337/94 dt.07.10.1994. Then, T.Raghavaraju has sold away Ac.1.00 cts to Sri B.Ramesh Chandra vide regd.Doc.No.216/95 dt.18.01.1995. The purchasers of the land have also been issued Pattadar Pass Books/Title Deeds for their portion of the lands in Sy.No.39/2 of Kommadi village.

Therefore, the land measuring Ac.5.00 cts in Sy.No.39/2 of Kommadi village of Visakhapatnam (Rural) is hereby de-notified from Sec.22-A of registration act and the purchasers of the land are permitted to sell away their portion of the land as the sales performed by them are found as permissible.
