ORDER:

One Smt. Bathula Adilakshmi W/o (Late). Gopal, resident of Visakhapatnam has submitted a representation requesting to issue NOC to sell away the land measuring Ac.4-88 cents covered by S.No.43/2 of Bakkannapalem Village of Visakhapatnam (Rural) Mandal, which was said to have been assigned in favor of her deceased husband under Ex-Servicemen category vide D.R.No.433/70, to meet her family needs.

The Tahsildar, Visakhapatnam Rural and the Revenue Divisional Officer, Visakhapatnam vide references 3rd and 4th read above respectively, have submitted their reports on the subject matter of the land, which discloses that, the applicant's husband Bathula Gopal, Ex-Serviceman was granted assignment for an extent of Ac.4-88 cts in S.No.43/2 of Bakkannapalem vide D.R No. 333/70 Dt.10.06.1970 by the then Tahsildar, Visakhapatnam and the name of the individual got mutated in connected Revenue Records. He was also issued PPB/TD under Khata No: 53 of Bakkannapalem Village and the land in question has been in peaceful possession and enjoyment of the applicant.

Further, as per the provision laid down vide G.O 1st read above, the Ex-Servicemen are free to sell away their assigned lands after a period of 10 years from the date of Assignment. The stipulated period of 10 years was already expired in the present case.

Therefore, in view of the circumstances stated above, the request of the applicant Smt. Bathula Adilakshmi W/o (Late) Gopal, Ex-Serviceman is hereby considered and accorded permission to sell away the land measuring Ac.4.88 Cts covered by Sy.No.43/2 of Bakkannapalem Village of Visakhapatnam Rural Mandal. Further, the land in question is hereby deleted from the list of Govt. lands notified U/s 22-A of Registration Act, 1908 (Amended Act, 2007)

The Sub-Registrar, Madhurawada is requested to take necessary further action in the matter.
