ORDER:

Sri Gudimetla Veereddi, Ex-Serviceman Arle village of K.Kotapadu Mandal. was granted D-Form Pata with an extent of Ac.5.00 Cts covered by Sy.No.297/1 of Arle village of K.Kotapadu mandal vide D.R No.149/99 dt.18.01.1991 as reported by the Tahsildar, K. Kotapadu and RDO Visakhapatnam read with the certificate issued by the Zilla Sainik Welfare Officer, Visakhapatnam, Pension Payment Order and Discharge Certificates produced by the D-Form Patta holder.

As per the provision laid down vide G.O.Ms.No.1117 Dt.11.11.1993 the Ex-Servicemen are free to sell away their assigned lands after a period of 10 years from the date of assignment. In this case the assignment was granted in the year 1991 and the stipulated period of 10 years was elapsed long ago.

Therefore, the request of the individual is hereby considered and granted NOC to sell away the land. Further, the land measuring Ac.5.00 Cts covered by Sy.NO.297/1 of Arle village of K.Kotapadu Mandal is hereby withdrawn from the list of Govt. Lands notified u/s 22-A of Registration Act, 1908.

The Sub-Registrar, K.Kotpadu is requested to take further necessary action in the matter.
