ORDER:

In the reference 1st read above, Sri M.J.G.Raju, Ex-serviceman has submitted a representation stating that he was granted assignment for the land measuring Ac.2.00 cts in Sy.No.248/6 of Gambheeram village in the year 1990, that he was also issued Pattadar Pass Book & Title Deed, and the said land is in his peaceful possession and enjoyment. He further stated that, he is suffering from ill health, he borrowed huge amounts for his medical expenses and hence he has requested to issue NOC to sell away the land.

The Tahsildar, Anandapuram and the Revenue Divisional Officer, Visakhapatnam, vide references 2nd and 3rd read above, have submitted reports, respectively, and stated that the applicant Sri. Mindi James Gidian Raju S/o Jacob, Ex-Serviceman was issued D-Form Patta for the land measuring Ac.2.00 Cts in Sy.No.248/6 of Gambheeram Village of Anandapuram Mandal, vide D.R No.90/90 dt.14.09.1990 by the then Mandal Revenue Officer, Anandapuram, and it is in his possession and enjoyment. His name got mutated in Revenue Records and he was also issued PPB/TD. Further, as per the provision laid down vide G.O.Ms.No.1117 Revenue Dept Dt.11.11.1993, the Ex-Servicemen are free to sell away their assigned lands after a period of 10 years from the date of Assignment.

Therefore, in the circumstances stated above, the representation of the applicant Sri M.J.G.Raju, Ex-Servicemen is hereby considered and accorded permission to the allottee to sell away the land measuring Ac.2.00 Cts in Sy.No.248/6 of Gambheeram Village of Anandapuram Mandal as per the provision laid down vide G.O.Ms.No.1117 Dt.11.11.1993. Further, the land in question is also herewith deleted from the purview of Sec.22-A of Registration Act.

The Sub-Registrar, Anandapuram is requested to take necessary further action in the matter.
