Sub: Lands Visakhapatnam district - Visakhapatnam (Rural) Mandal-Paradesipalem Village- Sy.No.187/1 Ac.4.89 cts Assigned to (late) Vasupalli Sattayya, Ex-Servicemen - Representation of Smt. V.Kurlamma Wife of deceased assignee requesting to issue NOC to sell away the land as per the provision laid down vide G.O.Ms.NO.1117 Dt.11.11.1993- Request considered - Orders issued.

ORDER:

One Smt. V.Kurlamma W/o (Late) Sattayya resident of Visakhapatnam, vide reference 2nd read above, has submitted a representation requesting to issue NOC to sell away the land measuring Ac.4.89 cts covered by Sy.No.187/1 of Paradesipalem Village of Visakhapatnam (Rural) Mandal in terms of G.O.Ms.No.1117 Dt.11.11.1993, which was said to have been assigned in favour her deceased husband under Ex-Servicemen category in the year 1978.

The Tahsildar, Visakhapatnam Rural and the Revenue Divisional Officer, Visakhapatnam vide references 3rd and 4th read above respectively, have submitted their reports on the subject matter of the land, which discloses that, One Sri.Vasupalli Sattayya, Ex-serviceman was assigned an extent of Ac.4-89 cts in S.No.187/1 of Paradesipalem Village vide D.R No.385/87 Dt.05.06.1978 by the then Tahsildar, Visakhapatnam. His name got mutated in connected Revenue Records. He was also issued PPB/TD under Khata No:24, and the land in question is peaceful possession and enjoyment of the applicant.

Further, as per the provision laid down vide G.O 1st read above, the Ex-Servicemen are free to sell away their assigned lands after a period of 10 years from the date of Assignment. The stipulated period of 10 years was already expired in the present case.

Therefore, in view of the circumstances stated above, the request of the applicant Smt. V.Kurlamma W/o Late Sattayya, Ex-Serviceman is hereby considered and accorded permission to sell away the land measuring Ac.4.89 Cts covered by Sy.NO.187/1 of Paradesipalem Village of Visakhapatnam Rural Mandal. Further, the land in question is hereby deleted from the list of Govt. lands notified U/s 22-A of Registration Act, 1908 (Amended Act, 2007)

The Sub-Registrar, Madhurawada is requested to take necessary further action in the matter.
