Smt. T.Shivakameswari W/o late Mohanbabu has put in a  
representation dated 06.03.2006 for grant of NOC to sell away the land said to be  
assigned to her husband (late) Sri T.Mohanababu in S.No.374/2 of Kapuluppada  
village of Bheemunipatnam Mandal under the Ex-serviceman quota.

The Govt. after careful examination of the matter, vide in the reference  
16<sup>th</sup> cited, have decided to approve the issue of NOC in respect of land to an extent  
of Ac.5.00 cts in Sy.No.374/2 of kapuluppada village in favour of Smt.  
T.Sivakameswari W/o (late) T.Mohan Babu, Ex-serviceman. Further, the Govt. have  
requested the District Collector Visakhapatnam to issue NOC as requested by the  
petitioner and denotifying the same in the records.

Therefore, Smt. T.Sivakameswari W/o (late) T.Mohan Babu is  
permitted to sell away the land for an extent of Ac.5.00 cts in Sy.No.374/2 of  
kapuluppda village of Bheemunipatnam mandal in terms of G.O.Ms.No.1117  
Revenue (Assignments) Dept Dated 11.11.1993. Further, the above said land is  
withdrawn from Sec.22-A of Registration Act.
